## Freedom of Information Request - FOI2024/00243

We are writing in response to your email received by Post Office Limited ("Post Office") on 31 January, which has been dealt with under the terms of the Freedom of Information Act 2000 ("FOIA"). We sincerely apologise for the delay in responding to your request.

In your email you have requested the information shown verbatim in bold below:

In usual circumstances, Post Office would respond to an FOI request by setting out whether or not it holds the information sought and either disclose the information held or apply an appropriate exemption if it would in some way be harmful to disclose the information. Sometimes, however, simply confirming whether or not Post Office holds the information sought would cause the same kind of harm as disclosing the information itself. In those circumstances, Post Office is not required to state confirm or deny whether or not we hold the information sought.

In this case, you have asked for information relating to a former postmaster whom you state was suspended. We can neither confirm nor deny whether we hold any information surrounding the suspension of a postmaster. The reason for this is that the fact of whether or not a postmaster has been suspended constitutes personal data and to confirm or deny if this has happened in this case would breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Confirmation or denial would not constitute 'fair' processing of the personal data because postmasters or Post Office staff would not reasonably expect us to reveal to the public, information relating to their contractual or employment matters.

It is important to remember that our stance of neither confirming nor denying whether we hold such information should not be taken as an indication that the information you requested is held by Post Office.

On a broader note, you may be interested in information about the redress arrangements for postmasters affected by Post Office's past failings related to the 2019 High Court findings that previous versions of the Horizon system had bugs, errors and defects that could have caused shortfalls in postmasters' branch accounts. The priority of today's Post Office is to ensure that postmasters affected receive redress as swiftly as possible. If you are dissatisfied with the handling of this response, you do have a right to request an internal review.
