Freedom of Information Request – FOI2024/00461

We are writing in response to your email received by Post Office Limited (“**Post Office**”) on 16 March 2024, which has been dealt with under the terms of the Freedom of Information Act 2000 (“**FOIA**”). We sincerely apologise for the delay in responding to your request.

In your email, you have requested the information shown verbatim in bold below:

“How many complaints/ disputes have been made from Post Office sub-postmasters about the Horizon software that was updated in 2017 (1) have been made, and (2) still need to be resolved, about discrepancies and cash shortfalls in individual post offices; and in what towns and cities these complaints were made.”

On 3 April 2024, we emailed you asking for clarification. On 4 April 2024, you replied to Post Office, saying:

“You seem not to understand your duties to me under section 16 of the Freedom of Information Act or section 45 Code of Practice that provides further guidance on how you can comply with your duty under section 16. I would ask in future correspondence with me you approach your duties within the Act in line with section 16.

My questions put to you on March 16 are as follows:

How many complaints/ disputes have been made from Post Office sub-postmasters about the Horizon software that was updated in 2017 (1) have been made, and (2) still need to be resolved, about discrepancies and cash shortfalls in individual post offices; and in what towns and cities these complaints were made.

So it's focused on the Horizon IT system that was updated in 2017. My question is clear.

It is clear from my questions that the focus is also on discrepancies and cash shortfalls in individual post offices; my question is clear. It is limited to this issue.

I now expect you to provide me with the information required and again remind you of section 16 of the Act”

We can confirm that Post Office does hold some information relevant to your request. Please note, we do not hold any information in the form that you have requested for any of your questions prior to 29 March 2021. Additionally, for the entire period that you have requested, we need to explain that the recording process in place does not directly categorise a complaint and/or discrepancy as being specifically related to the Horizon IT software. Therefore, in the spirit of transparency, we are providing the information we hold and have included more details below on how the information has been sourced against each part of your request.

To answer part 1 of your request: it may be useful if we explain that Post Office define as a complaint any contact which is received into our Branch Support and Issue Resolution Teams regarding an issue that the postmaster or their agent has experienced.

For the period of 29 March 2021 to 16 March 2024, a total of 13,298 complaints were reported to Post Office by postmasters or their agents. In the absence of a direct categorisation, which is not available on our system, we have searched the case notes of these complaints using a keyword search. We have found that 685 cases mention the word “Horizon”. However, it is not possible to know if any of these entries relate directly to a complaint about the Horizon software without manually reviewing them, which would take longer than the statutory cost limit available under section 12 of the FOIA. Out of the 685 cases returned using the keyword search, 1 case was still open as of 16 March 2024.

To answer part 2 of your request: it may be useful to first explain that Post Office defines a discrepancy as any difference between (i) the actual cash and stock position of a branch and (ii) the cash and stock position shown on Horizon as derived from transactions input by branch staff into the branch's terminals.

For the period of 29 March 2021 to 16 March 2024, a total of 12,579 cases of discrepancies were reported to Post Office by postmasters or their agents regardless of the reason behind the discrepancies.

Of this total figure, 490 were still open as of 16 March 2024. Please note that within the total figure of 12,579 discrepancies, there were 52 cases of discrepancies that were categorised as being due to technical or system issues. Unfortunately, there is no further categorisation available to understand if these relate specifically to Horizon or another system / technical issue encountered in branch. All of these 52 cases are closed.

To answer the last part of your request, which is asking for those towns and cities from where the complaints were made, we confirm that complaints and/or discrepancy reports were received from 1,320 different towns and cities.

Given the fluctuation in the number of Post Office branches that open and close from time to time in any given town or city, the number of open branches as of 29 July 2024 may not be an accurate reflection, in all cases, of the number that was continuously open in every relevant town or city for the duration of 29 March 2021 to 16 March 2024. The information we have provided reflects the position as of 29 July 2024.

In the Annex below, from the total of 1,320 towns and cities from which reports were received between 29 March 2021 and 16 March 2024, we have provided the names of only the 330 towns and cities, each of which had 10 or more Post Office branches open as of 29 July 2024.

The reason that we have been unable to provide all of the locations of the affected branches is because we have withheld the names of the towns and cities where there are fewer than 10 Post Office branches, under sections 40(2) and 40(3A) of the FOIA as this constitutes personal data relating to other persons. These sections exempt personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would breach any of the data protection principles in Article 5(1) of the UK GDPR.

We consider that disclosure of the names of towns or cities with fewer than 10 Post Office branches is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Disclosure of these names would not constitute 'fair' processing of the personal data, as it may lead to the identification of a postmaster where Post Office has received reports of complaints or discrepancies from their Post Office branch.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review. You can do this by writing to the address above within 40 working days of receipt of this response stating your reasons for your internal review request or alternatively, by emailing information.rights@postoffice.co.uk.

If, having requested an internal review by Post Office, you are still not satisfied with our response you also have a right of appeal to the Information Commissioner at:
